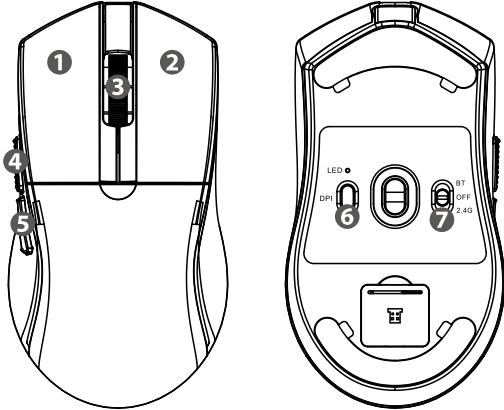

The computer will recognize and configure the mouse automatically, the mouse will be charging the battery at same time. 2.4G wireless connection Plug USB receiver into computer USB port, mouse connection mode switches on "2.4G", click any button, the computer will recognize and configure the mouse automatically BT Connection Mouse connection mode switch on "BT", LED indicator will be flashing in Blue, turn on the computer BT and searching for available device(win 7 or above OS), select device name" 5.1 Mouse", the computer will recognize and configure the mouse automatically. The mouse support adjust report rate [125Hz-250Hz-500Hz-1000Hz] (Not available on connection mode),when the computer didn't install software, press& hold [③],then press [④] to cyclic switch report rates, the LED will flash in White to indicating current report rate: 125Hz: LED flash 1 time. 250Hz: LED flash 2 times. 500Hz: LED flash 3 times. 1000Hz: LED flash 4 times.
